I further agree to indemnify and hold harmless and defend the SOUTH LYON AREA RECREATION AUTHORITY, and all parties involved, employees, directors, officers and affiliates from any and all claims resulting from injuries, damages and losses sustained by me and arising out of, connected with or in any way associated with the activities of the LEAGUE. I acknowledge that SOUTH LYON AREA RECREATION AUTHORITY is not responsible for any inclement weather or acts of God which may affect the LEAGUE and release and waive all claims against SOUTH LYON RECREATION, and all parties involved, directors, employees, officers and affiliates for damage or loss that may arise therefrom. I HAVE READ AND FULLY UNDERSTAND THE ABOVE WAIVER AND RELEASE OF ALL CLAIMS AND UNDERSTAND THAT BY SIGNING THIS DOCUMENT I HAVE AGREED TO WAIVE AND RELEASE ANY AND ALL CLAIMS THAT I MAY HAVE AGAINST SOUTH LYON AREA RECREATION AUTHORITY, AND ALL PARTIES INVOLVED, EMPLOYEES, DIRECTORS, OFFICERS AND AFFILIATES ARISING OUT OF MY PARTICIPATION IN THE LEAGUES.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19: The corona virus or COVID-19 is extremely contagious and thought to have caused a worldwide pandemic.
